

## **Request for Qualification (RFQ)**

### **1. Purpose and Scope**

Companies or consortia wishing to be considered as Qualified to bid on the PW Energy geothermal drilling programme are requested to complete the Request for Qualifications (RFQ), and to submit the completed RFQ in the manner described below. Qualified entities will be notified and invited to submit a tender or financial bid for a complete or turnkey package that includes all aspects of drilling, logging and well testing as shown in the Terms of Reference (TOR) document.

### **2. Format**

- 2.1. The completed RFQ shall include a listing of all companies to be involved in the project, stating their roles and responsibilities, and providing corporate resumes for all
- 2.2. The completed RFQ shall include a detailed description of all comparable drilling, logging and testing of geothermal wells to depths greater than 3,000 meters performed by the companies and individuals listed in 2.1, above
- 2.3. The completed RFQ shall list the years in which the activities stated in 2.2, above, were performed, and the duration in months and weeks involved in each activity
- 2.4. The completed RFQ shall include the approximate value in EUR of each of the activities carried out under 2.2, above

### **3. Legalities**

- 3.1. The completed RFQ shall list any and all lawsuits and arbitrations, pending or completed, arising from performance of the activities listed in 2.2, above, with outcomes where known
- 3.2. The completed RFQ shall state the willingness to obey the pertinent laws, rules and environmental regulations of the Slovak Republic; and shall list all reasons for any inability to obey such laws and regulations
- 3.3. The completed RFQ shall state the ability of the company or consortium to post a performance bond, being a percentage of the agreed fixed price, and shall explain any reason for any inability to post such a bond
- 3.4. PW Energy reserves the right to decide whether a company or consortium is Qualified, under terms of the TOR and RFQ; and by submitting a completed RFQ a company or consortium acknowledges and accepts that right without challenge


#### 4. Submittals

- 4.2. The completed RFQ must be received by PW Energy no later than noon of the fortieth (40th) day after the date of this RFQ. Submittals received later will not be evaluated
- 4.3. All submittals must be signed in ink by an authorized representative of the company or consortium submitting a completed RFQ, and a copy of the documents must be delivered electronically by e-mail to Mr. Michal Mašek [michal.masek@pwenergy.sk](mailto:michal.masek@pwenergy.sk). Sole e-mail and facsimile copies are not acceptable
